OUR SAFEGUARDING PROCEDURES

We have a full safeguarding policy in place and all instructors are DBS Checked to an enhanced level, with Stephen Luke being appointed as our safeguarding lead.

All Instructors hold a relevant safeguarding qualification that helps them identify the need for proper safeguarding protocols and deal with any concerns efficiently and effectively.
